CONSIDERING A LOAN WITH US?

You should carefully review this document and make sure you are aware of all your building's obligations - financial and otherwise. You should work with experienced legal counsel on this matter. You should feel comfortable that you are capable of meeting its obligations and you should make sure you understand the potential consequences should your building not meet any of its obligations.
